Your child is interested in attending After Prom to be held at Chagrin Falls Middle School from 12:00 am to 4:00am on May 20th. After Prom is free of charge and open to all juniors and seniors of Chagrin Falls High School and their prom date, regardless of whether they attend prom. If your child registers, but does not arrive at After Prom by 12:30 am they will not be admitted and you will receive a phone call. **All underclassmen and non-CFHS students must fill out the Guest Registration Form, NOT this form! No student or guest will be admitted to the After Prom without a completed registration form.**

***All students will be subjected to a passive, non-invasive breath analysis prior to entering the event. The Chagrin Falls High School Administration has authorization to administer the use of a breath-test instrument for the purpose of determining if a student has consumed an alcoholic beverage. It is not necessary for the test to determine blood-alcohol level. Refusal to submit to the use of the testing instrument or a positive test will result in denial of admittance to the After Prom, school consequences as outlined in the Code of Student Conduct and police referral. Containers, bottles or backpacks will not be permitted into After Prom, and the contents of purses will be checked.**
