- Course is based on the Ohio Driver Training Curriculum and consists of **24 hours classroom & 8 hours behind-the-wheel instruction**. A Certificate of Completion will be mailed to parent/student after student completes 24 hours classroom instruction **and** 8 hours behind-the-wheel instruction. Student must present Certificate to BMV at time of road test. If certificate is lost or destroyed, Ohio regulations require the issuance of a 2nd certificate (fee for 2nd certificate is \$15.00).
- Course tuition is \$349.00. **Tuition includes 24 hours classroom instruction & 8 hours behind-the-wheel instruction.** Tuition **also includes** gas & insurance for driving lessons, scheduling fees & training materials. Tuition is non-refundable after student begins classes.
- **Student does not need a Temporary Permit to begin Drivers' Ed classes.**
- To schedule the behind-the-wheel driving lessons (4, 2-hour lessons) call the driving school office at 440 248-8552. You can call to schedule the lessons after the first week of classes. Student will be scheduled when you call so long as student has a current temporary permit, tuition is paid in full and a signed copy of this form has been submitted. If student has a temporary permit (**not required to start classes**) record the following from the temporary permit card:

- **State of Ohio law requires student to complete all training within six months of the date student begins training.**
- If the student cannot make a scheduled behind-the-wheel driving lesson, student must notify the driving school or driving instructor **48 hours** before the scheduled driving lesson. The driving school will charge a \$39.00 cancellation fee if cancellations are not timely. Student must have a Temporary Permit Card in his/her possession for each driving lesson.
- The driving school and/or instructor may cancel a behind-the-wheel lesson due to adverse weather conditions/weather advisories/hazardous road conditions/extreme cold (wind chill)/extreme heat. The driving school shall furnish a licensed instructor and a dual-controlled car, fully-insured, for the purpose of instructing the student. State of Ohio regulations require the driving school to make all training available by _____; no later than six months after training begins.
- Optional: Use of the driving school's car for the license examination (road test) is not included in the tuition. Use of the driving school car for the road test is \$99.00. To schedule the use of a vehicle for the road test call 440 248-8552.
- Driver training schools are licensed by the State of Ohio Department of Public Safety through the Driver Training Program Office, 1970 West Broad Street, Columbus, OH 43223.
